**ORDINANCE NO. 1633 (2019)**

**AN ORDINANCE TO AMEND THE REVISED  
GENERAL ORDINANCES OF THE CITY OF SEA ISLE CITY,  
CHAPTER 7 ENTITLED "TRAFFIC" TO ESTABLISH TRAFFIC CONTROL  
SIGNALS, NO TURN ON RED, AND AUTHORIZE SEASONAL  
OPERATION OF TRAFFIC SIGNALS IN FLASH MODE**

**WHEREAS**, the City of Sea Isle City shall establish traffic control signals within the City; and

**WHEREAS**, the City shall establish no turn on red at established traffic signal locations; and

**WHEREAS**, with the passage of law by the New Jersey Department of Transportation, P.L. 2008, c. 110, municipalities and counties gained greater control over their traffic signals; and

**WHEREAS**, the City has determined that there is a substantially reduced traffic volume within the City during the off-season (October 15<sup>th</sup> through May 1<sup>st</sup>); and

**WHEREAS**, the City of Sea Isle City Police Department has obtained authority from the County of Cape May to set traffic signals on County-owned roads in Sea Isle City to flash mode on a seasonal basis in 2019; and

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Sea Isle City, County of Cape May and State of New Jersey as follows:

**SECTION I.** Chapter 7 Section 14 of the Revised General Ordinances of the City of Sea Isle City, entitled "NO TURN ON RED" is hereby amended to delete the following section in its entirety and replace same as follows:

**DELETED SECTION:**

**7-14 NO TURN ON RED.**

a. No person shall make a right turn on the red signal between May 1st and October 1st at any location as follows

1. Heading north on Landis Avenue at the intersection of John F. Kennedy Boulevard and Landis Avenue turning east.

2. Heading east on John F. Kennedy Boulevard at the intersection of John F. Kennedy Boulevard and Landis Avenue turning south.

3. Heading north on Central Avenue at the intersection of John F. Kennedy Boulevard and Central Avenue turning east.

b. No person shall make a right turn on the red signal between 10:00 a.m. and 10:00 p.m. May 1st through October 1st at any location as follows:

1. Heading east on John F. Kennedy Boulevard at the intersection of John F. Kennedy Boulevard and Central Avenue turning south.

c. No person shall make a right turn on the red signal between 4:00 p.m. and 10:00 p.m. May 1st through October 1st at any location as follows:

1. Heading east on John F. Kennedy Boulevard at the intersection of John F. Kennedy Boulevard and Park Road turning south.

2. Heading north on Park Road at the intersection of John F. Kennedy Boulevard and Park Road turning east.

**REPLACEMENT SECTION:**

**7-14 TRAFFIC SIGNALS.**

This provision shall provide for traffic control signals at intersections as permitted by N.J.S.A. 39:4-197.

**SECTION II.** Chapter 7 Section 14.1 of the Revised General Ordinances of the City of Sea Isle City, entitled “Traffic Control Signals Authorized” is hereby amended to add the following section in its entirety as follows:

**ADDED SECTION:**

**7-14.1 Traffic Control Signals Authorized.**

Traffic control signals shall be installed and operated at the intersections as described herein, where at an intersection with any County of Cape May road such signals shall be coordinated with the County.

Traffic Control Signals:

29<sup>th</sup> Street and Landis Avenue

33<sup>rd</sup> Street and Landis Avenue

JFK Blvd and Landis Avenue

JFK Blvd and Central Avenue

44<sup>th</sup> Street and Landis Avenue

44<sup>th</sup> Street and Central Avenue

53<sup>rd</sup> Street and Landis Avenue

63<sup>rd</sup> Street and Landis Avenue

86<sup>th</sup> Street and Landis Avenue

**SECTION III.** Chapter 7 Section 14.2 of the Revised General Ordinances of the City of Sea Isle City, entitled “Installation Standards” is hereby amended to add the following section in its entirety as follows:

**ADDED SECTION:**

**7-14.2 Installation Standards.**

The traffic signal installation shall be in accordance with the provision of an Act Concerning Motor Vehicles and Traffic Regulations, Subtitle 1 of Title 39 of the New Jersey Statutes; shall conform to the design and shall be maintained in operation, as authorized by the Department of Transportation.

**SECTION IV.** Chapter 7 Section 14.3 of the Revised General Ordinances of the City of Sea Isle City, entitled “No Turn on Red” is hereby amended to add the following section in its entirety as follows:

**ADDED SECTION:**

**7-14.3 No Turn on Red.**

a. No person shall make a right turn on the red signal between May 1st and October 1st at any location as follows

1. Heading north on Landis Avenue at the intersection of John F. Kennedy Boulevard and Landis Avenue turning east.

2. Heading east on John F. Kennedy Boulevard at the intersection of John F. Kennedy Boulevard and Landis Avenue turning south.

3. Heading north on Central Avenue at the intersection of John F. Kennedy Boulevard and Central Avenue turning east.

b. No person shall make a right turn on the red signal between 10:00 a.m. and 10:00 p.m. May 1st through October 1st at any location as follows:

1. Heading east on John F. Kennedy Boulevard at the intersection of John F. Kennedy Boulevard and Central Avenue turning south.

c. No person shall make a right turn on the red signal between 4:00 p.m. and 10:00 p.m. May 1st through October 1st at any location as follows:

1. Heading east on John F. Kennedy Boulevard at the intersection of John F. Kennedy Boulevard and Park Road turning south.

2. Heading north on Park Road at the intersection of John F. Kennedy Boulevard and Park Road turning east.

**SECTION V.** Chapter 7 Section 14.4 of the Revised General Ordinances of the City of Sea Isle City, entitled “Seasonal Operation of Traffic Signals” is hereby amended to add the following section in its entirety as follows:

**ADDED SECTION:**

**7-14.4 Seasonal Operation of Traffic Signals.**

Traffic control signals shall be set to seasonal flash mode from October 15<sup>th</sup> through May 1<sup>st</sup> each year at the intersection as follows:

1. Intersection of 33<sup>rd</sup> Street and Landis Avenue-yellow light to Landis Avenue, red light to 33<sup>rd</sup> Street.
2. Intersection of 53<sup>rd</sup> Street and Landis Avenue-yellow light to Landis Avenue, red light to 53<sup>rd</sup> Street.
3. Intersection of 86<sup>th</sup> Street and Landis Avenue-yellow light to Landis Avenue, red light to 86<sup>th</sup> Street.

**SECTION VI.** Severability. If for any reason any section of this Ordinance shall be declared illegal by any Court of competent jurisdiction, the remaining section of the Ordinance shall remain in full force and effect, notwithstanding.

**SECTION VII.** Repealer. Any Ordinance or provision thereof inconsistent with this Ordinance is hereby repealed to the extent of such inconsistency.

**SECTION VIII.** Publication. This Ordinance shall take effect immediately upon the adoption and publication in accordance with the law.
